If there are 10 jurors, then 9-1 is acceptable. If there are 9 or fewer jurors then the verdict has to be unanimous. The minimum period of time that the jury have to have been thinking about their verdict ('in retirement') before a jury can return a majority verdict is 2 hours 10 minutes.
